YOU MUST CLASSIFY YOURSELF FOR SKIER TYPE

DETERMINING YOUR SKIER TYPE IS YOUR RESPONSIBILITY!

Your skier type, height, weight, age and ski boot sole length are used by the shop to determine the release/retention settings of your ski bindings. Be sure to provide accurate information; any error may increase your risk of injury. Consult these descriptions to select your classification.



TYPE I

"Cautious Skiing At Lighter Release/Retention Settings"

TYPE I SKIERS:

- ski conservatively
- prefer slower speeds
- prefer easy, moderate slopes
- favor lower than average release/retention settings.

This corresponds to an increased risk of inadvertent binding release in a fall

- Type I settings apply to "entry-level skiers uncertain of their classification"

TYPE II

"Moderate Skiing At Average Release/Retention Settings"

TYPE II SKIERS:

- ski moderately
- prefer a variety of speeds
- ski on varied terrain, including most difficult trails
- see all skiers who do not meet all the descriptions of either Type I or III

TYPE III

"Aggressive Skiing At Higher Release/Retention Settings"

TYPE III SKIERS:

- ski aggressively
- normally ski at high speeds
- prefer steeper and more challenging terrain
- favor higher than average release/retention settings.

This corresponds to decreased releasability in a fall in order to gain a decreased risk of inadvertent binding release

EQUIPMENT RENTAL AGREEMENT AND RELEASE OF LIABILITY

PART I

1.) READ CONTRACT COMPLETELY. SIGN/INITIAL BOTH SIDES. 2.) PROCEED TO CASHIER. HAVE DRIVER'S LICENSE/I.D. READY.

1. I will read Part II of this agreement, and will be responsible for obtaining all of the information required by that section and will provide a copy of Part II to the user of this agreement. I will make no misrepresentations to the ski shop regarding the user's height, weight, and age or skier type.

2. I understand that **ALL FORMS OF SNOW-SLIDING**, including skiing and snowboarding are **HAZARDOUS** activities. I also understand that all forms of snow-sliding have inherent and other **RISKS OF INJURY, INCLUDING DEATH**, that reasonable care, caution, instruction and expertise cannot eliminate. I further understand that injuries are common and ordinary occurrences during these activities. I hereby agree to freely, voluntarily and expressly **ASSUME** and accept any and **ALL RISKS** of any injury to any part of the user's body while engaging in any form of snow-sliding.

3. I understand that the **Alpine ski equipment** being furnished by Snow Summit, Inc. or by Sierra Summit, Inc. or by any of their respective agents, employees, or affiliated corporations (hereinafter collectively referred to as "**Summit**"), forms all or a part of a ski-boot-binding system which will **NOT RELEASE OR RETAIN AT ALL TIMES OR UNDER ALL CIRCUMSTANCES**. I further agree and understand that any ski-boot-binding system does **NOT ELIMINATE THE RISK** of injuries to any part of the user's body. **If any Snowboard** is being furnished, I understand that these systems are designed to **NOT RELEASE** and do **NOT PROTECT** against injuries to any part of the user's body.

I hereby **FOREVER RELEASE SUMMIT**, as well as the equipment manufacturers and distributors from, and agree to indemnify them and hold them harmless for, **any and all responsibility or legal liability** for any injuries or damages to any user of any equipment rented with this form, **whether or not** such injuries or damages are caused by the **NEGLIGENCE OF SUMMIT**. I agree **NOT** to make a claim against or **sue Summit**, or any of the equipment manufacturers and distributors for injuries or damages relating to or arising from the use of chairlifts or surface tows, any snow-sliding activities and/or the use of this equipment. **I accept full responsibility** for any and all such injuries or damages.

I understand that **SURFACE CONDITIONS** on roads, parking lots, walkways, stairs and any other area exposed to the elements of nature are subject to the deposit, melting and refreezing of snow, rain, sleet, hail and ice, such that **WALKING OR OTHER DAILY ACTIVITIES, particularly in rented ski boots or snowboard boots**, may become **DANGEROUS**. **I FREELY ASSUME ANY AND ALL SUCH RISKS, INCLUDING THE RISK OF ANY NEGLIGENCE OF SUMMIT.**
